Sesto San Giovanni, November 26th, 2018 - In compliance with the authorization approved by the Shareholder meeting held on April 23rd, 2018, mainly to be used to service the stock option plans, Davide Campari-Milano S.p.A. (LEI code 213800ED5AN2J56N6Z02) announces that between November 19th, 2018 and November 23rd, 2018 it bought back, on the regulated market (MTA) managed by Borsa Italiana, 39,387 own shares at an average price of € 7.3287 per share for a total amount of € 288,655.51.

The transactions have been executed by Goldman Sachs International (GSI), (LEI code W22LROWP2IHZNBB6K528).
